The Junior Fairest of the Fair serves as an ambassador to the Ozaukee County Fair and learns to be a role model to Fair visitors, growing in self-esteem and speaking abilities. She or he will appear with the Fairest of the Fair at selected activities during 2020 Ozaukee County Fair, Sunday, August 2<sup>nd</sup>, and the 2021 Fair, July 28<sup>th</sup>-August 1<sup>st</sup>, 2021. The Junior Fairest will participate in parades in 2020 & 2021 (Grafton Christmas Parade, Saukville Memorial Day, Flag Day, or Cedarburg 4<sup>th</sup> of July) and will also attend Sundae on the Farm, the 4-H Variety Show, the 4-H Dance, and the 4-H Bunny Breakfast.

### Contest Rules:

- Contestant must be no younger than 11 and no older than 13 as of Jan. 1<sup>st</sup> of the current year.
- Contestant must complete the application and questions, following the instructions, along with the signed photo release.
- If selected, the contestant must be able to participate in events and can no longer apply to be Junior Fairest of the Fair.
- **A parent must attend all activities and events with the Junior Fairest.**

Please type the application and check for spelling or grammatical errors. **Our committee will select the four finalists based on essays alone; no names will be used in the selection process.** The committee will notify applicants about their status by June 1, 2020. The finalists must attend an orientation and photo session on Saturday, June 20<sup>th</sup> @ Noon, and the Judges' Interview on Saturday, August 1<sup>st</sup>, (times TBD), followed by the Competition at 4:00 PM, in the Ozaukee Pavilion, and photo session after the coronation.
